Davenport Schools Foundation Scholarship - The Davenport Schools Foundation Scholarship Fund was started by an initial gift from Elizabeth Schaller, a former West High School guidance counselor. Subsequent gifts to this fund continue to make larger awards possible. This year's recipient of the \$1000 scholarship is Jason Davis of Central High School. Jason is the son of Larry and Mary Davis and plans to attend Valparaiso University.

Lisa Arbisser Scholarship - The Lisa Arbisser Scholarship Fund was created by the Davenport Schools Foundation to honor Dr. Lisa Arbisser, past president of the board, for her outstanding efforts towards excellence in education in the Davenport schools. The \$500 scholarship recipient is Nikolai Fedorchak of Central High School. Nikolai is the son of Bernard and Virginia Fedorchak and plans to attend Iowa State University in the fall.

Class of '59 Scholarship - The Class of 1959 Scholarship Fund is made up of donations from members of the 1959 graduating class from Davenport High School. A Letter from President Tony Williams

The Davenport Schools Foundation Board is using the sliver of time between the academic years to do some strategic planning, so I am going to use this letter to highlight some of the issues we are developing.

Historically the Foundation Board has functioned as a committee of the whole on most issues and any standing committees have been peopled mainly by board members. We plan to expand on committee structure by establishing more standing committees and recruiting additional committee members at large from our very talented community.

One of our major issues has been developing a database of people who have a connection with the Davenport Schools be they alumni, former teachers and administrators, parents, or others who understand the importance of public education. Our secretary, John Korn, is working closely with Harris Publishing to produce a directory of Davenport graduates. The Harris project will also include an online community, which will be unveiled in 2008. leveraging community resources for Davenport Community Schools

Enhancing the Great Minds Program

In 2001, the Davenport Schools Foundation established the Great Minds Program. The Great Minds Program makes persons, places and performances available to students in the Davenport Community Schools with the goal of inspiring them to a greater awareness, appreciation and understanding of our community and world.

At its core, Great Minds activities advance “place-based education,” which promotes learning that is rooted in what is local--the unique history, environment, culture, economy, literature, and art of a particular place. The original design of Great Minds encouraged teachers to apply for funds through the Foundation to provide students with experiential learning opportunities to enrich their educational experience. While this process proved very beneficial to those students whose teachers apply, the Foundation has begun looking at the program to 1) identify gaps in the process, 2) align the program with the new strategic plan for the Foundation, 3) focus on developmental (asset) needs in the community, and 4) better align with the curriculum across the grade levels.

Beginning in 2007/2008, the Davenport Schools Foundation Great Minds program will take on two different faces – the original teacher-driven application process and a new enhancement project. The Great Minds enhancement project is an exciting venture that the foundation has spent several months developing that will utilize the knowledge and cooperation of educators, curriculum specialists and community members. The enhancement program will fully integrate curriculum, developmental assets and the community to benefit the students in the most effective and economically efficient way possible.

The Great Minds enhancement project for the 2007/2008 academic year will target Kindergarten through Fifth grade. The foundation is very excited to be able to expand the program to all of these grade levels and, in the future, hopes to touch each grade level with a Great Minds program that meets the new criteria. The enhancement programs for the upcoming academic year would not be possible if it was not for the generosity from our donors!

Harris Publishing Connects Alumni

The last few months have stirred a lot of Davenport Schools alumni to ask questions: “Who are these people from Harris Publishing asking questions? Is this legitimate?”

As Board Secretary and leader of this initiative, my name was on the postcards that went out in May. I know there has been a little bit of confusion and I'd like to address that.

First of all, yes, this is legitimate! Harris Publishing is a leading publisher of school directories, and they have published several editions for Davenport schools in the past. This new edition will be released around the December 2007 timeframe and will include all three Davenport high schools.

Part of Harris' commitment to this project is a great deal of research. They will use mail, telephone and internet to try and reach as many alumni as possible for accurate listings in the directory. Also, it is important to understand that they need to sell directories to stay in business, so the callers will encourage alumni to purchase a directory. The directories are a valuable resource, and I encourage everyone to consider making a purchase. They are not cheap, but they are a quality product.

The really exciting news, however, is what follows. Because of the size of our district, and our history with Harris, we qualify for a really important bonus. Harris will create and host an “online community” for all Davenport Schools alumni.

For the current students and recent graduates, this term will mean something. For most people in my age bracket, it will require some explanation.

If you are an alumnus who didn't receive information about the directory, there is still time! Just call 1-800-546-1052 to update your information!

“Online Communities” have sprung up big in the last 5 years or so. It means a group of people connected via the internet who mutually agree to share personal information. If you've never heard of MySpace or FaceBook, find someone under the age of 25 and ask them about it. Friends share photos, emails, gossip, etc. and this is currently a huge part of the culture of the younger generation. I believe it's blossomed for two reasons – it's easy, and it's fun!

The Harris online community we will get by the end of the year will be very similar to the FaceBook and MySpace systems. Users will be able to set up and edit their profiles and determine how much of their information is available to others.

Class reunions will now become much easier to organize. Graduates will be able to look for jobs back in their hometown, and if they are business owners here, they will be able to post job openings for grads who may be looking for an opportunity to move back. My wife and I are perfect examples of something that happens often – graduates move to the big city (in our case, Chicago), get married and have children, then choose to come back to the Quad Cities to raise their families. Our community needs to help bring our graduates back!

Harris has been providing the Online Community for colleges and private schools for many years. We will benefit from directory sales by getting the chance to have an online community hosted for us, more or less for free.

To become a subscriber will cost each user about \$15 per year. Even if an alumnus chooses not to subscribe, he or she will still be able to update his or her own profile.

More details will follow in the near future, as we will provide presentations to many outlets to increase awareness of this wonderful new opportunity we have.
