**SPECIAL CALL OPEN MEETING**

The Board of the Davenport Community School District in the Counties of Scott and Muscatine, State of Iowa, met on Tuesday, January 17<sup>th</sup> for a Special Call Open Meeting. The meeting was held at the Achievement Service Center, 1606 Brady St., Davenport, Iowa, in said District in the Jim Hester Board Room. President Johanson called the meeting to order at 7:25PM

**1. CALL TO ORDER FOR REGULAR MEETING**

**1.01** On roll call the following board members were present: Directors: Ralph Johanson, Linda Hayes, Julie DeSalvo, Jamie Snyder, and Clyde Mayfield. Rich Clewell and Dan Gosa participated by phone. Dr. Tate and other administrators were present.

**2. ITEMS REQUIRING ACTION**

**2.01 Resolution for Approval of Teacher Contract**

**Motion** by DeSalvo and seconded by Hayes the board approved the following resolution:

The Board of Directors of the Davenport Community School District (the "Board") and the Davenport Education Association (the "Association") are currently parties to a collective bargaining agreement which expires on June 30,2018.

The Board and the Association have each determined that it is in their respective interests to modify the terms of the existing collective bargaining agreement and to extend the term of the collective bargaining agreement.

By entering into an agreement to modify and extend the term of the existing collective bargaining agreement, the Board and the Association are each signifying their intent that the terms of the collective bargaining agreement will remain in effect through June 30,2020.

The Board and the Association are each aware that laws governing collective bargaining and other matters which may be addressed in the collective bargaining agreement are subject to being amended. It is the intent of the parties to maintain the terms of the collective bargaining agreement, provided that doing so is not in conflict with state or federal law.

The Board of Directors of the Davenport Community School District accepts and approves the Tentative Agreement entered into with the Davenport Education Association for the purpose and with the intent of modifying and extending the terms of the existing collective bargaining agreement between the parties.

By this Resolution, the Board signifies its intent that the terms of the collective bargaining agreement will remain in effect through June 30, 2020 as set out in that agreement.

All terms of the collective bargaining agreement will remain in effect through June 30, 2020, provided that maintenance of these terms is not in conflict with state or federal law.

**Discussion:** Clewell asked questions concerning the information that was discussed in closed session and Johanson explained this information had not been made public yet so he wasn't able to discuss.

**Vote: Ayes:** DeSalvo, Hayes, Snyder and Johanson. **Nays:** Mayfield and Gosa. Clewell abstained. Motion carried.

**2.02 – Approval of Food and Nutrition Services Negotiated Contract**

**Motion** by DeSalvo and seconded by Snyder the board approved the terms of the three-year negotiated contract for the Food and Nutrition Services Employee Group with the Davenport Community School District from July 1, 2017 - June 30, 2020.

**Vote:** All Ayes motion carried.

**2.03 – Approval of Para-Educators Negotiated Contract**

**Motion** by DeSalvo and seconded by Hayes the board approved the terms of the three- year negotiated contract for the Para-Educators Employee Group with the Davenport Community School District from July 1, 2017-June 30, 2020.

**Discussion:** None

**Vote:** Ayes: DeSalvo, Hayes, Mayfield, Snyder, Gosa and Johanson. Clewell abstained. Motion carried.

**2.04 – Approval of Secretaries Negotiated Contract**

**Motion** by DeSalvo and seconded by Snyder the board approved the terms of the three-year negotiated contract for the Secretarial Employee Group with the Davenport Community School District from July 1, 2017- June 30, 2020.

**Vote:** All Ayes motion carried.
